



Dear Riverstone Kindergarten, Grade 1, and Grade 2 Parents,

On Friday, August 23<sup>rd</sup>, the Riverstone Kindergarten, Grade 1, and Grade 2 classes will head out for a day on the Payette River. These river trips have been a great way to start an exciting new year as students continue to explore Riverstone outside the classroom.

Cascade River Company has been our partnered outfitter since Riverstone began these river trips. We will be rafting down the lower section of the main Payette River from Beehive Bend to the jet boat ramp just north of Horseshoe Bend. Cascade will provide guides, rafts, and life jackets. They will also provide a bus for those who are not driving personal vehicles. Parents should be assured that the trip is age-appropriate, and the Cascade guides will ensure that everyone has a safe and fun experience.

Holding with tradition and to make this a community-building event, **one parent of Kindergarten students are required to attend, and parents and family members of Grade 1 and 2 students may attend as well.** Those family members who are participating will need to pay \$30.00 and will **be billed to your Riverstone financial account.**

***All adults and children must return Cascade's Participant Agreement to your students teachers no later than Wednesday, August 21st. Please see attached document.***

Please read the following details about the trip closely. Parents who plan on participating and driving their own vehicle should pay close attention to pick-up and drop-off locations. A map and driving directions are available below.

## Fall 2024 – Payette River Rafting

### Schedule of Activities

8:30	Students arrive at school for normal morning classes
9:45	Begin loading Cascade bus or parent vehicles
10:00	Depart for Horseshoe Bend
11:15	Picnic lunch in Horseshoe Bend Park (immediately after the railroad tracks on the right) <i>*Students and participating parents need to bring their own lunches</i>
12:00	Load onto Cascade buses and drive to put-in at Cascade Raft Company headquarters
12:15	Fit life jackets, load rafts and begin raft trip
2:15	Float trip ends
2:30	Depart for Riverstone
3:30	Arrive at Riverstone in time for regular pick-up and school bus route

### What to Bring

Prepare to get wet on the river! Wear clothing that can get wet and dry fast. Check the weather before we head out, if it looks like the weather will be cooler; bring some dry clothes for the drive back. Reminder that Cascade will not provide any food; please pack a picnic lunch. Please keep your water guns and other water toys at home.

- Shorts or swimsuit
- T-shirt
- Sunglasses with Strap
- Hat
- Sunscreen
- River sandals or tennis shoes
- Packed lunch
- Water bottle
- Towel (optional)

### Parent Participation

**At least one parent of each kindergarten student must attend the rafting trip. Parents and family members are encouraged to raft with their students, and will be charged \$30/person, which will be billed to your Riverstone financial account.**

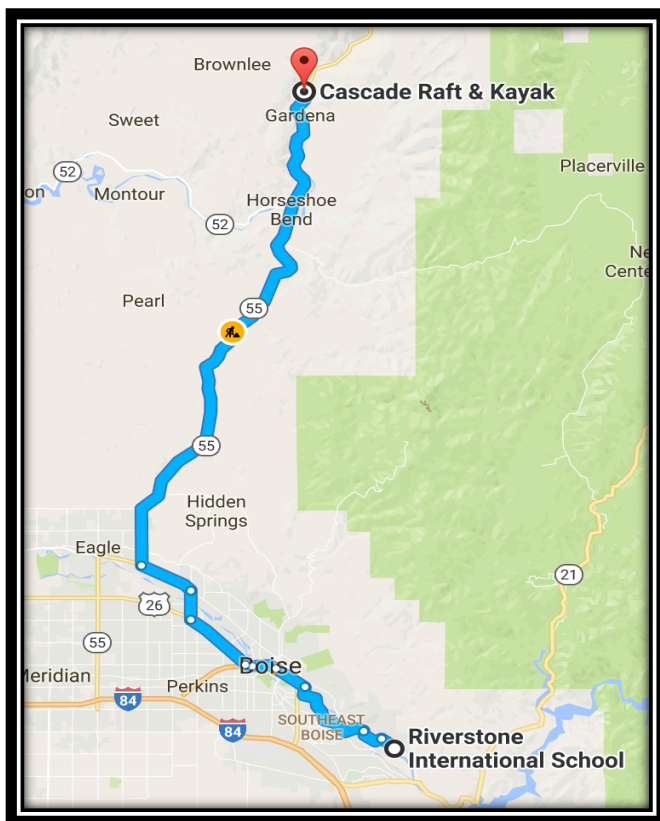
***Please sign up to raft with your students teacher no later than Wednesday, August 21st.***

## Use of Personal Vehicle

**\*\*Parents will not be able to ride the school bus this year. Please coordinate with other parents to carpool or drive yourself if you plan on attending.\*\***

Parents may choose to drive their children to and from the raft trip or ride on the bus. If you are going to be driving your own vehicle, please notify your student's teachers. **Parents may only drive their own children and children of parents riding with them. You must be in the same vehicle as your child.**

**Logistics:** Students riding with parents should either be picked up at 9:45 AM at school or meet the group at the park in Horseshoe Bend at 11:15 AM. After picking up any students, parents should proceed to the Horseshoe Bend Park (immediately after the railroad tracks on your right). When lunch ends, parents driving vehicles should drive to the take-out where they will leave their vehicles. **All Parents vehicles must be left at the takeout.** Please follow the Cascade bus to the jet boat ramp north of Horseshoe Bend. A second Cascade bus will then pick up and shuttle these parents and their students to the put-in at Cascade headquarters. **After the river trip, students driving back with parents must be signed out through teachers**



### Directions:

- From Riverstone International School head through downtown Boise or Chinden to Glenwood to State Street until you reach the turn off for ID-55
- Head north on ID-55 over a small pass until you drop down into Horseshoe Bend
- The preschool – grade 2 picnic lunch area will be the main park in the middle of town, which will be on your right after you cross the railroad tracks
- The take-out for preschool – grade 2 will be on your left after you cross the Payette after leaving Horseshoe Bend
- Cascade Raft and Kayak will be further north of Horseshoe Bend approximately 6 miles

RELEASE OF LIABILITY—READ BEFORE SIGNING**
